
To empower the women and other marginalized section of the society for their 'sustainable development.'

Our governance system

Bye-law of JEETA as empowered General Body as the supreme authority with Governing Body (Board) in down the line, constituted with 5 office bearers headed by the Chairperson. The other office bearers of the Board include Vice Chairperson, Secretary, Asst. Secretary and Treasurer. The Secretary acts as the Chief of the organization, responsible for day-to-day functioning as well as for programme implementation being helped by Programme/project staff and Treasurer for Finance & Administration. The Bye-law of the organization is there which elaborates the role and functional modalities of General Body, Office bearers and other members for effective governance of the organization. The Board meeting is usually conducted twice a year to review the progress and decide further course of action. The Annual General Meeting is conducted once in every year taking all members to approve

operational plan, budget, review the accomplishments and take major policy decisions.

OUR PROGRAMMES

Considering the local level issues and problems, JEETA has continued to intensify its effort on the sectors of Livelihood, Water, Health & Sanitation and Women Empowerment along with capacity building of the target communities within the broad framework of our vision and mission.

The major accomplishments during the year 2018-19 are succinctly articulated below.



I. Enabling the target communities to access safe improved water, sanitation & hygiene (wash) facilities



Envisioning WASH secured Deogarh District, JEETA has established partnership with Jalseva Charitable Foundation(Water Aid) since 2014-15. With the support and knowledge guidance from District Water & Sanitation Mission Deogarh, it is undertaken a project to enable the communities to access safe improved water, sanitation & hygiene (wash) facilities covering 7943 families with 146073 population in 240 villages of Barkote Block, focusing on the following aspects:

- Sensitizing the people and constructing toilet with the facility for Persons with disabilities (PwDs)
- Reconstruction and renovation of damaged toilets
- Orientation to School cabinets, Teachers and School Management Committees (SMCs), PRI members and other duty bearers on WASH.
- Participation and putting agenda on WASH deprivation in Palli Sabha/Gram Sabha
- Quarterly follow up with PRI members
- Wall painting of baseline map with multi-vulnerability marking
- Models demonstration (Stream based PWS) in one intensive GP
- Developing standard O&M system for WASH in AWCs
- Interface of PwD forum with DWSM for resource allocation towards PwD accessible toilets
- Developing Hygiene promotion teaching learning materials, hygiene promotion calendar

It is worthwhile to mention that advocacy efforts such as: Liaisoning with Gram Panchayats, Block Level Officer, PD DRDA, Collector, Executive Engineer of RWSS are going on to ensure fund allocation for outreach village to construction & water. Despite of our sincere efforts there are PwDs yet to access toilet & water facilities.

II. Enhancing food & nutritional security:



With a view to arresting the problems of food insecurity and nutritional deficiencies among the target constituencies a project titled, 'Enhancing food &

nutritional security through System of Rice Intensification (SRI) & System of Millet Intensification (SMI) has been implemented in 27 villages of Barkote & Pallahara Block of Deogarh & Angul District since last three years with the assistance of Jamsetji Tata Trust, targeting 2425 households with 12126 population.

The introduction of method of System Intensification in rice, wheat, millet and pulses has resulted in significant yield whereas investment cost is lesser than in case of conventional method. It is very much appreciated by the local farmers, which is evident from the increasing of farmers and areas covered adopting this method in number year by year. The main strategies espoused to make this programme successful are mentioned below.

- Capacity building and handholding support provided to the farmers in the field.
- Application of organic manures.
- Timely input support of quality seeds and devices for weeding.
- Interface meeting of farmers with the agricultural experts for proper guidance
- Sharing of experiences among themselves

III. Capacity building of the statkeholders:



Reproductive & Child Health (RCH) is one of the grey areas in the area which needs proper attention. Keeping this in mind, with the support of National Rural Health Mission, Deogarh, JEETA has continued its effort is to capacitate the Accredited Social Health Activists (ASHAs) who play a vital role of service providers in the community level. Details of the capacity building programmes undertaken in this reporting period are explained below.

Local Panchayat, is the vital institution and PRI members are the key players in the local self-governance system for ensuring community development activities. JEETA has taken a noble step to capacitate the local PRI members laying emphasis on women PRI members, and has established a District Resource Centre with the support and guidance of National Alliance of Women, Odisha chapter (NAWO) through DRDA, Deogarh. PRI members (Samity members, Sarpanchas, Naib Sarpanches and Ward members) of Barkote, Block of Deogarh District have been imparted with training and orientation programmes which are mentioned below.

Staff capacity building on different themes and issues is also one of the major organizational strategies. This initiative is intrinsic within the different programmes which enable the staff members to enhance their knowledge base to relate with the ground level situations and consolidate the lobby & advocacy efforts.

IV. Conducting different issue based campaigns:



Mass campaign is made in four villages of Pallahara Block to sensitization children and their parents on potential risks in job/work sites, child safeguarding & protection measures to be undertaken, Early mirage prohibition Act, Juvenile justice



Act etc. With the support of CARD Bhubaneswar.

Odisha Election Watch Campaign is launched In Angul District at the District Collectorate with the presence of PD DRDA, Deputy Collector, Asst Collector, DSWO, DIPRO, DEO, DCPO,Gouri along with College students, AWWs NGOs & other govt. Officials.

CONCLUDING REMARKS

We are proud to conclude that we have served to our target people meaningfully by addressing the local issues, exploring livelihood opportunities, converging with the Govt. line department, though our endeavour was not so enormous in this reporting period. More we work better we learn. Year by year we are enhancing our learning, skills and experiences by working for and with our communities We also vow to

continue work efforts in the direction of conserving local resources, empowering communities, reducing poverty, food insecurity, vulnerability in our target areas.

We express our sincere thanks to all our supporters such as: donors, community members, well-wishers, board members, staff and volunteers who have always been sources of inspiration for us and hope this will also continue in the coming years

STORY OF CHANGE MAKERS

Nearly more than 30 years back, some of the villagers of Kadaldhi village of Barkote block of Deogarh district came out of the village due to scarcity of drinking water to settle down near a stream (Gadia) which was later recognized as Gadia village. It constitutes of only 16 families belonging to SC/ST (Schedule Caste & Schedule Tribes). Since its formation the inhabitants were using the stream water for drinking water and going for the open defecation near the stream making the water & sanitation condition very poor & unhygienic. It might be one of the contributory factors for the poor health condition of the villagers especially the children which came out as a major concern during the rural appraisal conducted by JEETA in the year 2017, Realizing the issue due to the effort of the villagers and the team members of JEETA, a village WaSH committee as decision making body to implement WaSH programme in the village. The villagers were sensitized and motivated and as a consequence by the end of January 2019, followings are achieved.

- Two sanitary wells are dug by mobilizing the support of Gram Panchayat and Water Aid. It is pertinent to mention that out of total expenses, 20% was contributed by the villagers through labour and local materials.
- One bore well excavated which is to be fitted with hand pump by the Grampanchayat.
- Villagers promised for not use of stream water as drinking water.
- One water recharge pond is constructed with support of Gram Panchayat by utilizing MGNREGA fund.
- Resolution has been passed by villagers for O& M of newly created drinking water source.
- Individual Household latrine covering all the 16 households constructed with the support of GP by utilizing MGNREGA fund
- People are exercising the habit of disposing of solid and liquid waste.
- Women groups, who earlier concentrated on the single activity of thrift & saving, are now involved in WaSH activities.

The approach has been truly a participatory one, facilitated by JEETA with support of Water Aid and institutionalized by PRI department. However, the true key agents of change have been the women and adolescent girls who have emerged as local change makers. The village is now looked as model for other villages nearby.

Millet Farmer Trishala Sethi the change agent for millet promotion






Name- Trishala Sethi,Village- Taldihi,G.P- Pechamundi,Block- Pallahara,District- Angul

Trishala Sethi a small farmer of Taldihi of Angul District. He belongs to SC community. There are 4 members in the family & depend upon agriculture and collection of NTFP. During the period of his grandfather his family involved in was growing various millets along with paddy cultivation. He came to know about SRI in village meeting organized by JEETA in their village. He became aware about the importance of this technique & also knew that SRI technique can be adopted in ragi cultivation also. When he knew about the nutritional value of ragi he decided to grow ragi adopting this technique which he left.

With the help of JEETA staffs Trishala learnt the process of seed treatment, preparation of organic fertilizer, pesticides and their use. Though he was adopting SRI for the first time, He took 0.2 acres of land for which he used 60 grams of ragi seeds. He treated the seed with cow urine & prepared seed bed. He transplanted the seedling in 10 inches spacing when it becomes 11 days. He transplanted single seedling but mechanical weeding could not possible because of water scarcity. He used only organic fertilizer (*jibamruta*) & compost. To prevent pest he also used organics (*handi oushadha*). Average 5 tillers 2 productive tillers came & he got 23 kg of ragi from that patch of land. According to him he is happy with this production. Since water scarcity was there & proper weeding could not done production affected. But due to use of organic pesticide, his crop was not affected with pest and diseases.


